This event is rain or shine.

Vendors are required to complete application form by April 1, 2015.

Spaces are limited and will be assigned on a first-come, first-served basis.

Size of booth is 12x12. If larger booth is needed you must pay for additional booth spaces.

The Classic Antique Power & Tractor Show Committee reserves the right to accept or deny any or all applications.

You must provide your own tables and display shelves.

Food vendors are required to arrive Thursday, April 10<sup>th</sup> by 3:00 PM. Food vendor fire inspections will be at 8:00 AM on Friday.

The Committee asks that you do not leave until the festival is over each day.

Sunday, April 12 will be clean up day.

The Classic Antique Power & Tractor Show is not liable for damages, injury, or loss by any person/or entity or for goods from any cause whatsoever. We do not suggest leaving any valuables in your booth overnight. There will be paid security on site from 11:00 PM – 7:00 AM on Thursday, Friday, and Saturday nights.

The festival is a family event, all items displayed or sold must be in “good taste”. This is up to the discretion of the Classic Antique Power & Tractor Show Committee.

Absolutely no weapons or no alcoholic beverages are allowed for consumption or sale.

## BENSON VENDOR FIRE SAFETY REGULATIONS 2015

On behalf of the Benson Fire Department, we would like to welcome you to the Classic Antique Tractor Show. We ask that you as an exhibitor please comply with all state and local fire codes.

### \*\*FIRE INSPECTIONS ARE REQUIRED FOR THE FOLLOWING\*\*

1. ALL concession stands or any vendor that uses utilities to operate their business.
2. ALL tents that is equal to 200 square feet or larger. (Larger than a 12x12 tent)
3. ALL tents where cooking will take place inside or under the tent.  
\*Note: Any canopy or tent structure under which cooking operations are being conducted must be flame resistant and have a tag permanently affixed to the canopy indicating that its flame resistance.
4. ALL trailers, stands or any other situation where cooking will take place.

### EXHIBITOR REQUIREMENTS

1. ALL exhibitors must have a MINIMUM of a 5 pound ABC Fire Extinguisher that has been serviced and TAGGED within the last year  
\*Note: Disposable one time use extinguishers are not acceptable.
2. ALL exhibitors that are using deep fat fryers MUST have a Class K fire extinguisher.  
\*Note: The Class K must be in a dedicated location within 30 feet travel distance of the cooking appliances. The Class K must have been serviced and TAGGED within the last year.
3. ALL fire extinguishers and emergency exits shall be visible and accessible at all times.
4. ALL Liquefied Petroleum Gas (LPG) tanks must be secured to prevent tipping or falling.
5. ALL Electrical cords must be of adequate size to supply the appliances they are operating. All electrical cords must be maintained in good condition without splices, deterioration, or damage. All electrical cords shall be grounded when serving grounded portable appliances. All electrical cords must be routed so as not to pose hazard.
